What data do we collect?

Force Ten Survey Ltd only collects data if you fill in one of our website contact forms or email us direct. Under those circumstances, we collect the following data:

- Personal identification information (Name, email address, phone number, etc.)

How do we collect your data?

You directly provide Force Ten Survey Ltd with the data we collect. We collect data and process data when you:

- Register online, fill in an online contact form, email us direct, or place an order for any of our services.
- Voluntarily complete a customer survey or provide feedback on any of our social media / website message boards or via email.
- Use or view our website via your browser's cookies.

How will we use your data?

Force Ten Survey Ltd only collects your data so that we can:

- Carry out work commissioned by you, answer any enquiries / questions you may have and manage your account.

Force Ten Survey Ltd will not share your data with any third parties and we will not send you an unsolicited emails.

How do we store your data?

Force Ten Survey Ltd securely stores your data on a password protected secure computer and Wix.com secured online portal.

Force Ten Survey Ltd will keep your personal contact information indefinitely unless you instruct us otherwise. You have the right to be forgotten and, on request, we will permanently delete all data we hold about you.

Marketing

Force Ten Survey Ltd will not send you any unsolicited emails or marketing materials, or share your contact details with any third parties. Our website is advertising-free so no data is collected for these purposes.

What are your data protection rights?

Force Ten Survey Ltd would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Force Ten Survey Ltd correct any information you believe is inaccurate. You also have the right to request Force Ten Survey Ltd to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Force Ten Survey Ltd erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Force Ten Survey Ltd restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Force Ten Survey Ltd's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Force Ten Survey Ltd transfer the data that we have collected to another organisation, or directly to you, under certain conditions. If you make a request, we have one month to respond to you.
